



CHAPTER 1606 – CHECK LIST (Montgomery GI Bill for Selected Reserve)

1. New student or not attended SAC VA in last 3 years:

- ___ Certificate of Eligibility (COE) or E-Benefits Eligibility
- ___ VONAPP confirmation page w/confirmation number/date/time (initial visit ONLY)
- ___ DD 214-member4 copy (if available) or / Service 2 copy (if available)
- ___ DD Form 2384-1 Notice of Basic Eligibility (NOBE)
- ___ Military transcripts – unofficial copy ___ College Transcripts (unofficial copy)
- ___ VA 22-1995 – Change of Program or Place of training – SAC VA office
- ___ Program of Study (Audited & Signed by VA Certified Advisor) – SAC VA office
- ___ Copy of Photo I.D. – SAC VA office
- ___ Student Responsibilities – SAC VA office
- ___ Print the following after registering for courses - Student Detailed Schedule;
Account Summary; General Student Record; Unofficial Transcripts – ACES Account

2. Former Student and not attended SAC VA for one year or more:

- ___ VA 22-1995 – Change of Program or Place of Training – SAC VA office
- ___ Program of Study (Updated/Audited/Signed by VA Certified Advisor) – SAC VA office
- ___ Copy of Photo I.D. – SAC VA office
- ___ Student Responsibilities – SAC VA office
- ___ Print the following after registering for courses - Student Detailed Schedule;
Account Summary; General Student Record; Unofficial Transcripts – ACES Account

3. Students with current SAC VA file:

- ___ Request to use benefit every term at the SAC VA office – Priority Certification Deadline
- ___ Print the following after registering for courses - Student Detailed Schedule;
Account Summary; General Student Record; Unofficial Transcripts – ACES Account

4. Guest Student:

- ___ 315 – Parent Letter (Call or ask SAC VA office for details)
- ___ Certificate of Eligibility (COE) or E-Benefits
(needed if 315 *does not* state eligibility percentage)
- ___ Copy of Photo I.D. – SAC VA office
- ___ Student Responsibilities – SAC VA office
- ___ Print the following after registering for courses - Student Detailed Schedule;
Account Summary; General Student Record; Unofficial Transcripts – ACES Account

STEPS TO USE VA EDUCATIONAL BENEFIT AT SAN ANTONIO COLLEGE VETERAN AFFAIRS

STEP 1: COMPLETE SAC ENROLLMENT PROCESS

Before requesting to use your VA educational benefit at SAC, you will need to be fully enrolled and registered for your courses. If you are a prior Alamo Colleges student and have not attended for 12 months, you may need to re-apply. If you are a new student, registration will occur at New Student Orientation. If you are a transfer student (other than Alamo colleges), allow Admissions and Records at least 15 business days to evaluate transcripts. For assistance with the enrollment checklist, visit the DWC on N. Main or call (210) 486-0040.

STEP 2: VA EDUCATIONAL BENEFIT AT SAC

Apply for your benefit through the Veterans Online Application (VONAPP) which can be found on the webpage: <https://vabenefits.vba.va.gov/VONAPP>. If you are unsure about your benefit or need assistance applying for your benefit, schedule an appointment with the VetSuccess on Campus counselor at San Antonio College by calling (210) 486-0111 or stopping by the SAC VA office. If you have not already applied for your VA Educational benefit, you may do so during your appointment; be sure to bring checking account number and routing numbers to ensure direct deposit of the benefit.

STEP 3: SUBMIT MILITARY TRANSCRIPTS

1. Submit an official copy of your military transcripts (AARTS, SMART, CCAF, and CGI) to the SAC Admissions Office for evaluation. Submit transcripts to San Antonio College, Admissions and Records - FAC 216, 1819 N. Main Ave., San Antonio, Texas 78212.

2. Request additional “unofficial copy” of the military transcript to be turned into the SAC VA.

To request transcripts for ARMY/NAVY/MARINE CORP/COAST GUARD/SMART, go to the webpage:

<https://jst.doded.mil/>. To obtain AIR FORCE (CCAF) transcripts, go to the webpage:

<http://www.au.af.mil/au/ccaf/transcripts.asp>. Request that transcripts are sent to your home address.

STEP 4: DECIDE ON A PROGRAM OF STUDY

In order to use Veteran Educational Benefits at SAC, students must declare a career track and a program of study that SAC offers. If the student is still undecided on a career and their program of study, schedule an appointment with a Career Counselor in the Transfer and Career Center (TRAC) by calling (210) 486-1500 or stopping by the TRAC in the Moody Learning Center. Once decided on a program of study, be sure to declare your current program of study and primary institution through SAC Admissions and Records. STEP 5: ACADEMIC ADVISING

Students will need to meet with a VA certified Advisor and obtain an authorized program of study for their VA file. New/transfer students need at least one hour for “New SAC Student” advising. Copies of all unofficial college transcripts and CLEPS will be reviewed.

STEP 6: REQUEST TO USE VA EDUCATIONAL BENEFIT AT SAC

The SAC VA office will not take ANY documents until ALL necessary documentation can be submitted in order to certify to the VA.
